# Announcement of conditions for the admission of Russian and Belarusian students for the academic year 2022/2023

Under § 49 and § 50 of Act No. 111/98 Coll., on Higher Education and Amendments and Supplements to Other Acts for Admission to Bachelor's and Master's Degree Programmes and other related study regulations, I hereby announce the conditions for the admission and study of Russian and Belarusian students in connection with the ban on the provision of technical assistance to specific persons.

It is not possible to take any measures against students solely based on their nationality in the Russian Federation or the Republic of Belarus. Any action should only be taken on a legal basis based on the sanctions imposed within the European Union against the Russian Federation and the Republic of Belarus in connection with the armed conflict on the territory of Ukraine. Admission of students is governed by the instruction MSMT-11649/2022-1.

The fact that a person is a national of the Russian Federation or the Republic of Belarus is not a reason for any adjustment of the person's studies. For the university to proceed, it is primarily necessary to assess whether the study programme falls within the areas subject to sanctions (so-called critical).

The analysis of these study programmes is based on the <u>methodological recommendation of the FAU</u>, which is available on the FAU website.

#### The admission of students:

Universities are not competent to assess the personal sanctions regime, but only sanctions related to the prohibition of the provision of technical assistance, i.e., access to potentially critical curricula or information.

Applicants for study in a critical study programme from the Russian Federation and the Republic of Belarus (detected under the methodological recommendation of the FAU, i.e., which sanctions based on the EU Council Regulation should be applied) may be offered the option of studying in another (non-critical) study programme or offered an individual study plan excluding critical subjects. If the applicant meets the admission requirements and enrolls in a critical programme of study. The appropriate procedure is to interrupt the study, which will be decided based on the direct enforceability of the EU Council Regulation.

An applicant for study in a non-critical programme of study, if he/she fulfills the conditions for admission to study, must be admitted to study and therefore has the right to enroll.

If an applicant from the Russian Federation or the Republic of Belarus applies to study at the university, they should be informed in advance that the Ministry of the Interior does not currently issue new visas to persons from the Russian Federation and the Republic of Belarus. Visa extensions are possible.



However, the fact that a visa has not been granted is not a reason for non-admission to study or for interruption of studies.

The student is not obliged to notify the university if he/she has not obtained a visa. However, if he/she does not obtain a visa, he/she has the option to ask the university to interrupt his/her studies. If he/she does not apply for the interruption and does not attend classes, the relevant procedure is to terminate studies according to the provisions of § 56(1)(c) of the Higher Education Act.

#### **Current students:**

The fact that a person is a national of the Russian Federation or the Republic of Belarus is not a reason for any adjustment of the person's studies.

In connection with the Methodological Recommendation of FAU at the Faculty of Economics and Management, I declare the Master's degree programme for the academic year 2022/23 to be a critical study programme.
