

Organization of the admission procedure for doctoral study programmes POE, MAN, RSD in Czech, SEEE, MAN, RSD in English, commencement of studies in the academic year 2020/2021

In accordance with the provisions of *Section 49, Paragraph 5 of Act No. 111/1998 Coll. About universities and about amendment of other laws* Faculty of Economics and Management of the Czech University of Life Sciences of Prague publishes the following information related to the organization of the admission management into newly accredited doctoral study programmes (DSP) Podniková a odvětvová ekonomika (POE), Sector Economics and Economics of Enterprises (SEEE), Management in Czech (MAN in Czech), Management in English (MAN in English), Regionální a sociální rozvoj (RSR) and Regional and Social Development (RSD).

Admission procedure to DSP POE, MAN, RSR in Czech, SEEE, MAN, RSD in English

Date of admission procedure

The admission procedure to the above DSP will take place on **June 10, 2020**. In the case of serious reasons, it is possible to participate in the admission procedure in the alternative date that takes place on the 26th of August 2020. The Dean decides on the alternative date of the admission procedure at the request of the applicant, who is obliged to prove the need for a replacement date.

Submission of applications for the admission procedure

Applications are submitted via the internet application at <http://is.czu.cz>:

for DSP Management (in Czech and English) from 9. 4. 2020;

for DSP POE and SEEE from 15. 4. 2020;

for DSP RSR and RSD from 22. 4. 2020.

The deadline for applications is **May 20, 2020**. More information to complete applications can be found on the faculty's website in the **Science and Research section**.

Conditions for admission

The condition for the admission of a candidate is the passing of an entrance examination, the content of which is:

1. Expert discussion assessing the preconditions for independent scientific and research activity and knowledge of the field on the basis of proof of own creative work applicants - for the purposes of the professional discussion, the applicant submits a written report of which the intention of the dissertation in the extent of a maximum of 1 page A4, no later than 7 days before the date of the entrance examination.
2. Oral interview verifying knowledge of English and a second world language.
3. Assessment of the results in the master's degree programme (or in the last two years in the case of a five-year study programme) based on the arithmetic average of all studied subjects.

Based on the entrance examination, the Admissions Committee will issue an evaluation of the applicant, inclusive opinions on whether it recommends accepting applicants for doctoral studies.

Decision to accept and notify candidates

The Dean of the faculty decides about the admission to study on the basis of (1) the result of the entrance examination and (2) the recommendation of the head of the relevant department. The applicants will receive the result of the admission no later than 15 days after the completion of the admission procedure.
